- (iii) Execution of approved State Action Plan,
- (iv) Review implementation and achievement of child related outcomes,
- (v) Analysis of lagging district and supportive action,
- (vi) Finalization of working arrangements for inter-sectoral coordination,
- (vii) Coordination with NGOs/Donors/other agencies and organizations,
- (viii) Review of expenditure,
- (ix) Release of funds to the District Societies, as per Annual Action Plan,
- (x) Establish Resource Group of Professional to facilitate design and implementation of the core strategies, and
- (xi) Any other task assigned by the State Mission Steering Group.
